Our health and safety principles

We sincerely believe in the protection of our employees and others who may be affected by our activities. The prevention of injury and illness is an indispensable part of our business culture.

Our health and safety management system defines the responsibilities at each level in the business, provides direction on how to identify and manage workplace risks, and how we will meet or exceed legislative requirements.

Our statement of general policy commits us to:

- Making a continuous effort to prevent accidents and cases of work-related ill-health
- Providing adequate and appropriate information, instruction and supervision for employees
- Maintaining safe and healthy working conditions
- Providing effective control of the health and safety risks associated with all our activities
- Setting, monitoring and reviewing health and safety objectives
- Undertaking regular measuring and monitoring to check health and safety performance
- Providing a clear definition of corporate and individual roles and responsibilities
- Employing competent and qualified people, and providing additional training as necessary
- Consulting with our employees on matters affecting their health and safety
- Providing and maintaining safe plant and work equipment
- Assessing the risks arising from hazardous materials, and, where necessary, identifying processes for their safe handling and use
- Assessing our compliance with legal requirements and taking action where we identify deficiency
- Continuously reviewing and updating the management system to mitigate risk
- Empowering our employees and contractors to challenge and rectify any unsafe act or condition
- Continuously improving our health and safety performance in order to meet the world-class standards we are setting across the project
- Promoting this policy to our people and our contractors, and working with them to develop best practice
- Applying this policy to all aspects of the HS2 Ltd business
- Providing the resources needed to implement, monitor, review and update this policy so that it remains effective and relevant

By 'design', I mean looking back at all of those practices and conditions that have caused people harm in the past and looking for new and innovative ways that are less likely to hurt people.

While designing for tomorrow, we need to think about today. If you see something that you think looks unsafe, it probably is – so please report it.

By the same token, if you are ever asked to do something that you feel is unsafe, challenge it – whether this is someone doing something that looks unsafe, or it is the condition of equipment or infrastructure that worries you. You are all fully empowered to stop any task that looks unsafe, and will always have my support in doing so. Even if it turns out that the task was safe, it is always the right thing to stop and check rather than assume it is safe.

I need every one of you to work with me in developing a culture where health and safety is always front of mind.

HS2 Ltd really can set new standards for safety and I look forward to working with you to achieve this.
